That the Marion Area Multi Agency Emergency Telecommunications Center (METCOM) designates Gina Audritsh, Executive Director, as an authorized signer of the Lease Purchase Agreement Jumber 7707, by and between the Marion Area Multi Agency Emergency Telecommunications Center (METCOM) and Government Capital Corporation.
